

The Central European time in the CS OTE on 30th October 2022

The warning:

The daylight saving time (DST) will change at 3 a.m. to the Central European time on 30th October 2022, so that clock from 3 a.m. will be adjusted backward to 2 a.m.. Therefore **the electricity delivery day 30th October 2022 and the gas day 29th October 2022 will have 25 trading hours.**

The impact on the electricity market participant

The conditions for the submission of the bids to the CS OTE Portal during the change from the daylight saving time to the Central European time are as follows:

The Realization diagram submission

The delivery day 30th October 2022 will have 25 trading hours - you will fill in volume (amount) for trading hours 1,2,3,4 to 25.

You can use a web form for correct RD submission.

For delivery day 30th October 2022 the ScheduleTimeInterval, MatchingPeriod and TimeInterval must be in the following format: „2022 -10-29T22:00Z/2022 -10-30T23:00Z“
Otherwise the realization diagram will be rejected!

For delivery day 31st October 2022 the ScheduleTimeInterval, MatchingPeriod and TimeInterval must be in the following format: „2022 -10-30T23:00Z/2022 -10-31T23:00Z“

Example:

trading hour 1 is for time interval 0:00 – 1:00, trading hour 2 is for time interval 1:00 – 2:00, **trading hour 3 is for time interval 2:00 – 3:00, trading hour 4 is also for time interval 2:00 – 3:00** (repeated time interval after the time change), **trading hour 5 is for time interval 3:00 – 4:00** ,.....and trading hour 25 is for time interval 23:00 – 24:00

The day-ahead market bids submission

The delivery day 30th October 2022 will have 25 trading hours - you will fill in volume (amount) for trading hours 1,2,3,4 to 25.

Example:

trading hour 1 is for time interval 0:00 – 1:00, t. h. 2 is for time interval 1:00 – 2:00, **trading hour 3 is for time interval 2:00 – 3:00, trading hour 4 is also for time interval 2:00 – 3:00** (repeated time interval after the time change), **trading hour 5 is for time interval 3:00 – 4:00** ,.....and trading hour 25 is for time interval 23:00 – 24:00

The intra –day bids submission

The delivery day 30th October 2022 will have 25 trading hours - you will fill in volume (amount) for trading hours 1,2,3,4 to 25.

Example:

trading hour 1 (contract *_00-01_XB) is for time interval 0:00 – 1:00, t. h. 2 (contract *_01-02A_XB) is for time interval 1:00 – 2:00, **trading hour 3 (contract *_02A-02B_XB) is for time interval 2:00 – 3:00, trading hour 4 (contract *_02B-03_XB) is also for time interval 2:00 – 3:00** (repeated time interval after the time change), trading hour 5 (contract *_03-04_XB) is for time interval 3:00 – 4:00 ,.....and trading hour 25 (contract *_23-24_XB) is for time interval 23:00 – 24:00

The impact on the gas market participant

The conditions for the submission of the bids (nominations) to the CS OTE Portal during the change from the daylight saving time to the Central European time are as follows:

Nomination, renomination

As usual, you will submit only one volume (amount) for the whole day **with the exception of the transport nomination** but you should take notice that **the gas day 29th October 2022 will have 25 trading hours.**

Hourly nominations of transport will be in a message NOMINT as follows:

The deadline of nomination's window (**valid for nomination on 29th and 30th October**) will be set to 00:00 CEST, 1:00 CEST, 2:00 CEST, 3:00 CET, etc. (so nomination's window between 2:00 CEST a 3:00 CET will take 2 hours due to the time change).
