



## Overview of the introduction of 15-min. MTU products on short-term electricity markets operated by OTE

As of July 1, 2024, the Czech Republic will switch to a 15-min. ISP (Imbalance Settlement Period). From the same moment, the cross-border trading of 15-min. products will be gradually introduced on the short-term electricity markets operated by OTE.

Specifically, the changes will be reflected in the following way:

- **Day-Ahead Market (DM)**
  - until Q1/2025 (the exact date will be specified) the products will remain only at 60 minutes in the view of the decision to implement the 15-min. MTU within the single day-ahead market (SDAC) at one moment (in Q1/2025)
  - from Q1/2025 (the exact date will be specified) 15-min. products will be introduced, while the possibility to trade the 60-min. products will be maintained
- **Intraday Market – Continuous Intraday Market (IM)**
  - Until June 30, 2024 (delivery day) it will be possible to trade only 60 min products
  - From July 1, 2024 (delivery day) it will be possible to trade both 60 min and 15 min products; the cross product matching functionality (i.e. matching products with different granularity) will not be supported
- **Intraday Market – Intraday Auction (IDA)**
  - June 6, 2024 (delivery day) launch of IDA
  - Until June 30, 2024 (delivery day) it will be possible to trade only 60-min. products
  - From July 1, 2024 (delivery day) it will be possible to trade only 15-min. products (meaning that 60-min. products will no longer be supported)

Within the Czech Republic/OTE, the transition to 15 min ISP is linked to a number of other changes: e.g. the start of data metering in 15 min granularity as of July 1, 2024 (in accordance with the legislation on metering), impact on the hourly green bonus, etc.
